1. Except for one-person households, in situations not listed above, the standard of disposable for each additional family member refers to the middle-low-income household standard approves by the applicant's local municipal or county(city) competent authority under the Public Assistance Act.

2. The calculation of disposable assets does not include the applicant's residence or private agricultural land which has declared present market value below NTD5,500,000. (present market value should be below NTD 8760,000 in Taipei) The total value of disposable assets increases by NTD150,000 for each additional family member.
