### Brief overview of Legal aid Services

After adopting new, democratic Constitution in 1992, which guarantees human rights and freedoms and free legal aid - The legal aid services in Mongolia was provided as following:

- 1994-2002 Association of Mongolian Advocates was responsible for organization of Legal aid in Mongolia.
- 2002-2013 Association of Mongolian Advocates was appointing cases to advocates as an obligation/responsibility.
- 2004-2006 Ministry of Justice and Home affairs in cooperation with Soros Foundation have established and ran two Legal aid centers

### Brief overview of Legal aid Services

During the legal reform of 2013 in Mongolia new laws regulating Legal aid services were adopted:

- Law on legal aid for the indigent defendants (2013)
- Law on Legal status of Lawyers (2013)
- Criminal Procedure Law (2017)

The Legal aid services are regulated by these laws at the moment.

### LEGAL AID ORGANIZATIONS

### LEGAL AID CENTER

- Law on legal aid for the indigent defendants (2013)
- Total 52 State Attorneys in Mongolia
- Legal aid is provided to defendants in the criminal cases only

Legal aid and advocacy services provider for Indigent citizen's committee next to Mongolian Bar Association

- Law on Legal status of Lawyers (2013)
- Total 141 lawyers with a voluntary membership
- Legal aid could be provided to criminal, civil and administrative cases



- Date of Establishment: 2014
- Total number of applications received in the past year: 2,904
- Total number of Applications Approved in the past year: 2,648
- Total number of Applications Rejected in the past year: 256
- Total number of Legal Aid Lawyers: 52
- Total number of Non-Legal Professionals: 20
- Government budget and total legal aid expenses in the past year: 866,618,800 tugriks (approximately 350,000 USD annually)

### LEGAL AID CENTER

- Established in 2014 Legal aid Center organizes and coordinates the work of 52 "State attorneys", who are working in 21 provinces of Mongolia and six districts in Ulaanbaatar city.
- Legal aid center is part of Ministry of Justice and Home Affairs, therefore Government organization.
- The State is responsible for funding of Legal aid Center, which is around 866,618,800 tugriks (approximately 350,000 USD) annually.

### STATISTIC DATA OF LAST YEAR

The classification and percentage share of cases resolved in court or before going to the court by state attorneys in 2017 as follows:

- Theft 744 or 38,7%;
- Causing of light, heavy and serious intentional injury to human health 435 or 23%;
- Disturbance of public peace 129 or 6.7%;
- Robbery 120 or 6%;
- Violation of vehicle safety and operational rules 97 or 5%;
- Murder 69 or 3.6%;
- Other crimes 326 or 17%
