# KLAC : Eligibility Criteria of Legal Aid

- Citizen, foreign resident with low income
- Farmer, Fisherman
- Recipient of Basic Livelihood Security, Basic Old-age Pensioner
- Disabled Person
- National Meritorious Person
- War Veteran

## KLAC : Eligibility Criteria of Legal Aid

- Person injured in Righteous Behavior and his family, the bereaved family of a righteous person
- Military Veteran discharged from mid- or long-term service not eligible for military pension
- Worker or Alien Worker with average monthly income under 4 mil.won, whose wages are overdue

# KLAC : Eligibility Criteria of Legal Aid

- Applicant for individual rehabilitation /bankruptcy & immunity
- Victim of Domestic Violence
- Victim of school violence
- Multi-cultural Family by marriage immigration or naturalization
- Single-parent Family
- Minor without Guardian

# KLAC : Eligibility Criteria of Legal Aid

- Criminal Victim
- North Korean Defector
- Unregistered Person: For Registering Procedure
- Victim of school violence
- Court-granted Litigation-Aid
- Court-appointed Public Defender
- others, including foreign residents, who are unable to seek a legal relief or justice

## Representing Victims in Criminal Procedure:

- Sexual Crime (Mostly Female Victims)
- Child Abuse Cases
