Definition of Civil Society


- It is realized that genuine civil society consists of four sectors:
- (1) government (Executive Branch and Parliament),
- (2) individuals and private enterprises that form an economic force,
- (3) state institutions supporting good governance
- (judiciary, commissions and other independent governmental agencies), and
- (4) independent organizations and media.




Government Supporting Good Governance

Normally Recognized Civil Society Organizations

1. Rights Based Associations

(Human Rights, Workers' Rights, Farmers' Rights, Ethnic Rights, etc.)

2. People's Organizations or Interest Groups

(Trade Unions, Teachers' Associations, Lawyers' Associations, Women's Organizations, etc.)

- 3. Academic Institutions (Universities and Research Groups)
- 4. Issue Oriented Organizations (NGOs, Non-profit Organizations)
- 5. Development Organizations and Foundations (Health, Education, Agriculture, etc.)
- 6. Racial, Religious and Cultural Institutions
- 7. Social Welfare Assistance Groups

Legal Aid and Neutrality Issue

- Neutrality: You should not make any conclusion, based on subjectivism, with having sufficient documentary or/and oral evidence.
- Non-neutrality: You cannot be neutral if you have sufficient documentary or/and oral evidence.
- Truth seeking: Even though you don't want to take side with the victims of crimes, you are responsible to seek truth, to uncover truth and to struggle for truth.

Superior/Command Responsibility

• Superior/command responsibility is a form of responsibility for omission to act: a superior may be held criminally responsible under that doctrine where, despite his awareness of the crimes of subordinates, he culpably fails to fulfill his duties to prevent and punish these crimes.
