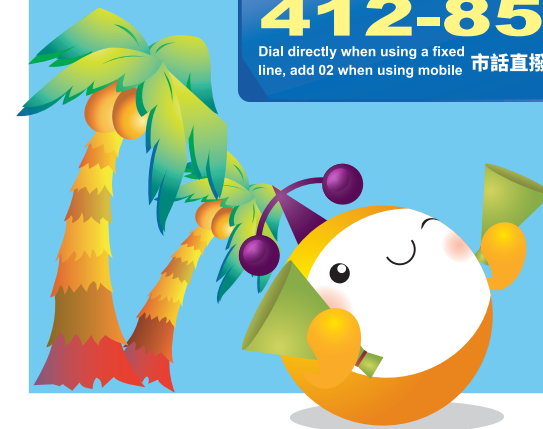

WHO CAN APPLY? 誰可以申請？

If you are lawfully living in Taiwan, you may apply for legal aid if:

- your legal problem is reasonable
- Low, mid-to-low-income households, or people whose income or property value is below a certain threshold. (For more details, please visit www.laf.org.tw)

* Compulsory defense cases do not require financial assessment.

* Identified victims of human trafficking and foreigners living in shelters pending identification as victims of human trafficking may also apply.

- 法律案件要有道理

SPECIAL PROGRAMS 特殊專案



● Habeas Corpus Case Accompanied by Legal Aid Attorney Program

Apprehended or arrested suspects or friends or family of suspects may apply for the service.

Applicant requirements:

1. Apprehended or arrested by institutions other than court.
2. Have a writ of habeas corpus or court referral.

● 提審案件律師陪同專案

被逮捕、拘禁之人或其親友都可以申請律師陪同！

申請要件：

1. 被法院以外之任何機關逮捕、拘禁
2. 經法院核發提審票或經法院轉介

● First Criminal Interrogation Accompanied by Legal Aid Attorney Program

Applicant requirements:

1. Punishable by a minimum sentence of no less than three years' imprisonment.
2. Requested to be interrogated for the first time.

● 檢警第一次偵訊律師陪同到場服務

申請要件：

1. 涉及三年以上有期徒刑的案件
2. 第一次接受訊問



DOCUMENTS YOU NEED TO BRING 申請所需文件



- ARC card, passport or R.O.C. National ID Card.
- Tax forms of your income and assets in Taiwan (you may apply for them at the National Taxation Bureau).
- Documents related to your case.
- If your family or friends apply on your behalf, they must bring a letter of authorization and should be familiar with your case.

- 您的居留證或護照或身分證
- 您在台灣的財產清單、所得清單（可向國稅局申請）
- 相關官司案件資料
- 如果由親友代為申請，需要具備您的委託書，並且熟知您的案情
